NEXT STEP: Send to Registration Office:

1. This completed and signed **APPLICATION TO REGISTER A LITTER**. If you were NOT the owner of the dam at the time of mating, include the completed and signed Supplemental Litter Registration Breeder Information form
2. (Optional) **SUPPLEMENTAL SIGNATURE FORM** if dam has more than 2 owners.
3. Completed and signed **STUD SERVICE CERTIFICATE** from the owner(s) of the sire. If sire is not registered with the CKCSC-USA, also include the items listed in #4 below.
4. (Optional) **SUPPLEMENTAL SIGNATURE FORM** if the sire has more than 2 owners.
5. **DNA Profile** Letter or Certificate from the AKC for the sire and dam, unless already on file with the CKCSC-USA Registration Office.
6. (Optional) **TRANSFER OF DOG** form for individual puppies, signed by both the litter owner(s) and the New Owner(s).
In which case the original CKCSC-USA Pedigree Registration Certificate will be sent to the new owner.

READ BEFORE SENDING:

1. Only litters whelped in the USA and owned by a resident of the USA are eligible for litter registration with the CKCSC-USA.
2. **The Code of Ethics obliges all members resident in the USA to register every eligible Cavalier they breed with the CKCSC-USA.**
3. Only Cavaliers registered with or eligible for registration with CKCSC-USA at the time of mating, shall be used for breeding. Any Cavalier duly registered with any CKCSC-USA Approved Foreign Registry, which includes the American Kennel Club (AKC), is eligible for registration with the CKCSC-USA.
4. For unregistered sires from an Approved Foreign Registry that are not obligated for registration with the CKCSC-USA, litter application must include the following items:
 - a) a **clear, color copy** of the Three-Generation Export or Certified Pedigree from the dog's country of origin;
 - b) a **clear, color copy** of the Registration Certificate from the dog's country of origin showing ownership of the sire in the dog's country of origin.
5. The affix of the breeder will be used as a prefix on the names of the puppies s/he breeds. If the breeder has not yet submitted an Application for Registration of an Affix or is not yet eligible to apply for a CKCSC-USA Affix, then the CKCSC-USA Affix, "REGIS", will be used. The complete name (i.e., breeder's affix plus name) by which a Cavalier is originally registered must not exceed 25 characters (up to 15 additional characters may be added for an extra fee) except in the case of a Stud Fee Puppy. No punctuation is allowed. Any numerals used in the naming must either be spelled out or in the form of Roman numerals. Duplicate names will automatically be suffixed with the next sequential Roman numeral for that name.
6. Since any Stud Fee Puppy belongs to the stud dog owner at whelping, the stud dog owner is entitled to name that puppy. The owner of the stud dog must use his/her registered affix in addition to that of the breeder in naming a Stud Fee Puppy. In this case, the puppy will be named with the breeder's affix first, followed by the affix of the stud dog owner, followed by the name of the puppy. In such cases, only the breeder's affix, plus the name of the puppy, will be counted for the 25 character limit. A space, but no punctuation, will separate the two affixes.
7. This Application to Register a Single Sire Litter must be submitted (postmarked) to the Registration Office within six (6) months of the date of whelping to avoid a late fee and within one (1) year to avoid an additional late fee. If it is not submitted (postmarked) within eighteen (18) months of the date of whelping, an additional Penalty Fee will be imposed and **the litter will not be registered without the approval of the CKCSC-USA Registration Committee.** Note: All late fees and penalty fines are cumulative and in addition to the regular fees.
8. The CKCSC-USA will not register any dog which is sired by, or out of, a Cavalier owned or co-owned by any person who is **suspended, expelled or denied CKCSC-USA privileges** where any breeding date is shown to be subsequent to the date of disciplinary action.
9. A Cavalier who has been restricted from breeding shall not be bred. Should it be bred, its get/produce will not be eligible for registration with the CKCSC-USA and the member will be subject to punitive action by the CKCSC-USA Board of Directors. **Revocation of a breeding restriction must be RECORDED by the Registration Office before the mating takes place.**
