**NEXT STEP: Send** to Registration Office:

1. This completed & signed **APPLICATION TO REVOKE A RESTRICTION**.
2. **ORIGINAL CKCSC-USA PEDIGREE REGISTRATION CERTIFICATE.**
3. **If the CKCSC-USA Board imposed the restriction(s), include a letter stating why you are requesting this revocation(s).**
4. **CORRECT FEE** (see Fee Schedule in Bulletin or on Website: [www.ckcsc.org](http://www.ckcsc.org)). (Note: All fees doubled for non-members.)

## READ BEFORE SENDING:

1. Only the person(s) who imposed a restriction upon a dog may revoke that restriction(s). The litter owner(s) should consider very carefully the circumstances of the dog who was restricted from breeding, including that there is both the time and the financial ability to care properly for it, whether it be a stud dog or brood bitch, and for any forthcoming litter.
2. It is important to understand that until the CKCSC-USA Registration Office has received and recorded the revocation of a breeding restriction, that Cavalier may not be used for breeding. If a mating occurs prior to the revocation recording date, any resulting litter will not be registered by the CKCSC-USA and the owners of both the sire and dam of any resulting litter will be in violation of the CKCSC-USA Code of Ethics.
3. One or both restrictions imposed can be revoked at any time, but **ONLY** by the person(s) who originally imposed them. **Any restriction from breeding must be revoked PRIOR to any breeding taking place.** Revocation of one or both of the restrictions must be made on this Application For Revocation Of Restriction. **NO REVOCATION OF RESTRICTION WILL BE RETROACTIVE.**
4. No restriction(s) shall be revoked, nor terms for revocation be made, which will place any owner in violation of the Bylaws, the Code of Ethics, or the Policies of the CKCSC-USA.
5. The CKCSC-USA Certified Pedigree will be endorsed on the back with the Revocation(s) revoked and the date on which such Revocation(s) is effective, and then returned to the current owner.
