READ BEFORE SENDING:

1. **PLEASE DO NOT WRITE ON THE BACK OF THE CKCSC-USA PEDIGREE REGISTRATION CERTIFICATE.** It is for Registration Office use only. The Registration Office will record the change in ownership on the back of the CKCSC-USA Pedigree Registration Certificate and forward it to the new owner-
2. If the effective date is left blank on a transfer, the effective date of transfer is the date the Transfer of Dog form was received in the Registration Office. No transfer can be retroactive for the purposes of breeding.
3. It is the responsibility of the owner(s) transferring the dog to see that the original CKCSC-USA Pedigree Registration Certificate, this Transfer of Dog form and the required fee are submitted to the Registration Office in a timely manner. All transfers must be submitted (postmarked) within six (6) months of the date of signature.
4. In the case of a Stud Fee Puppy, no Transfer is required from the litter owner(s) to the Stud Dog Owner(s), as the puppy belongs to the Stud Dog Owner(s) at the time of whelping. No restrictions may be imposed on a Stud Fee Puppy by the litter owner(s), since the puppy belongs to the Stud Dog Owner(s) at the time of whelping.
5. Both the current and new owners must sign the form in the applicable area(s) – either under the area indicating no restrictions or under each restriction imposed. Using the restriction(s) on this form will ensure that any restriction(s) imposed will be honored by the CKCSC-USA.
6. If a dog is to be co-owned, all co-owners must agree to the transfer and all must sign this Transfer of Dog form and, if necessary, the Supplemental Signature Form. All CKCSC-USA documents will be sent to the new owner, as indicated on this Transfer.
7. The CKCSC-USA strongly recommends that, when effecting a transfer, you not undertake any mating until you have received the CKCSC-USA Pedigree Registration Certificate, recording the transfer of ownership to you without any breeding restriction imposed.
8. Either one or both of the restrictions listed on this Transfer of Dog form may be imposed on any Cavalier, regardless of its age, by its current owner(s) at the time of transfer. Such restriction(s) will be imposed for the duration of its lifetime unless revoked. The person(s) imposing the restriction(s) should make clear, preferably in writing, the conditions, if any, under which any restriction(s) might be lifted.
9. Either or both of the restrictions imposed can be revoked at any time, but **ONLY** by the person(s) who originally imposed them. Revocation of restriction(s) must be made on the Revocation of Restriction form. **Any restriction from breeding must be revoked PRIOR to any breeding taking place. NO REVOCATION OF RESTRICTION WILL BE RETROACTIVE.**
10. Any person who is suspended, expelled or denied CKCSC-USA privileges, will be denied the privilege of transferring dogs. If a dog is co-owned with a person who is **suspended, expelled or denied CKCSC-USA privileges**, his/her signature is not acceptable on any required CKCSC-USA form(s).

Considerations

Co-ownerships: Many co-ownerships have become problematic over such issues as who is to show the dog, who is responsible for veterinary care, who is responsible for breeding, for the undertaking and the cost of testing and for overseeing all related matters. It is advisable to consider a written contract setting out all contingencies and agreements prior to signing a transfer form containing a co-ownership. Please see the CKCSC-USA Registration Policies and Procedures for more information on co-ownerships.

Breeding Restrictions: It is greatly to the breed's benefit to restrict from breeding all Cavaliers considered not appropriate for breeding and all dogs too young to be cleared for inherited health problems. The CKCSC-USA strongly encourages litter owner(s) to impose the "not to be used for breeding" restriction upon the puppies they place, until such time as the puppy reaches maturity and exhibits the quality necessary to permit it to produce a litter, and, above all, passes the necessary tests for genetic problems, particularly regarding hearts, eyes, hips and patellae.

WARNING

No transfer, or terms of transfer, shall be made which will place any owner in violation of the By-laws, the Code of Ethics or the Policies and Procedures of the CKCSC-USA.
